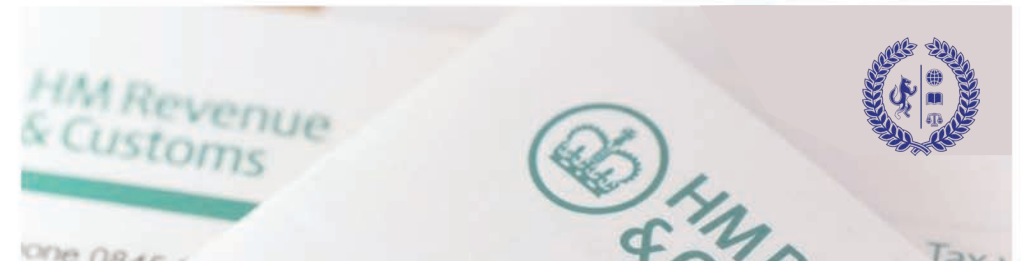

FREQUENTLY ASKED QUESTIONS

Which proof of income do I need to buy house to live for the first time?



If you are Employee, you need to prove your finances with payslips of at least the last 3 months with a steady income from the same employer.

If you are Self-employed, you need to prove your income with the Tax Calculation (SA302) and Tax Overview of at least 1-2 years ago.

How much money for deposit do you need to buy a house?

Normally you will need at least 10% of the value of your home to make a deposit

What are the costs you must pay when buying a house?

Depending on the value and geographical location of your home, you will have to pay for many different fees. Below, we list some of the main fees:

- Mortgage Advising Fee, also known as Arrangement Fee
- Appraisal fee (if any)
- Soliciting fees
- Stamp Duty if the value of the house is within the scope of the Stamp Duty fee.
- Other fees paid to other parties such as Land Register, Telegraph Transfer, etc.



MORTGAGE PROCEDURES



PREPARE DOCUMENTS

The Mortgage Broker guides the customer through all the document required such as credit check, money laundering check, etc.



APPLICATION

Lodge the application to the bank. Followed by a valuation cost before issuing an official offer (this step could take from 2 to 4 weeks).



EXCHANGE

Success application mean offer will soon arrives in the post. Loan procedures take place.

TYPES OF COMMON VISAS IN THE UNITED KINGDOM

UK Visitor Visa

Required Documents:

- Current passport & Old passports (if any)
- National identity card (ID Card)
- Household Registration Book
- 3 months worth of Bank Statements
- Saving Account
- Work Certificate/ Labor Contract/ Business Registration Certificate (if any)
- 3-6 month salary/ Tax receipt
- Proof of property ownership: real estate, cars, etc.

Family member - EU Residence

Required Documents:

Similar to the UK Spouse/ Partner Visa, the financial proof for EU Residence includes payslips of the last 3 months and work contract.

* Required income for 2019



UK Spouse/ Partner Visa

Required Documents:

- Current passport of both wife and husband.
- A1 Certificate or UK Bachelor Degree
- Registration of marriage (in English)
- Financial proof: total income of both wife and husband must be at least £18,600 before tax*
- Proof of property ownership (house contract, bills, etc.)



UK Parent of a child Visa

The child must be under 18 by the time you submit the application.

The child must be a British Citizen or settled in UK for 7 years.

Required evidence:

- You must be true parents of your child
- You must have sole parental responsibility for your child
- The child will live with you
- You must have adequate accommodation for yourself and the child (proven by house contract, bills, etc.)
- Proof of property ownership (house contract, bills, etc.)

UK Divorce procedure

Required documents: registration of marriage, cause of divorce + information and address of wife/husband in order for the court to send the papers.

Processing time: within 6 months



START UP AND INNOVATOR VISA

Visa Tier 1 Entrepreneur has been replaced by Start-up Visa and Innovator Visa from 4/2019

Required documents:

- Both of the Visa need an endorsement from a UK higher education institution (HEI) or a business organisation with a history of supporting UK entrepreneurs
- Start-up Visa is for students who have studied in the UK and have ideas and ambition to start a business for the first time while Innovator Visa is for entrepreneurs who already had experience and would like to opt for investment in the UK.
- Start-up Visa does not have Financial Requirement while Innovator visa require the minimum fund of £50,000.
- Start-up Visa lasts for 2 years and does not lead to settlement (applicants can change to Innovator after 2 years). Innovator Visa lasts for 3 years and can lead to settlement after 5 years.



REPRESENTATIVE OF AN OVERSEA BUSINESS VISA

Who can apply:

- The sole representative of an overseas company planning to set up a UK branch
- An employee of an overseas newspaper, news agency.

English requirement minimum: CEFR level A1, in speaking and listening.

The sole representative must hold a senior position within the company,

NATURALISATION

Who can apply:

- Have indefinite leave to remain or settled status for 12 months
- You will not need to wait 12 months to apply if you are married to a British Citizen

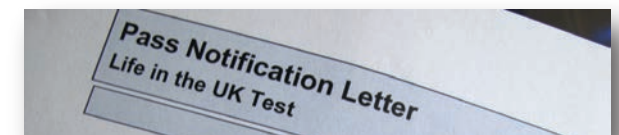
Requirement:

- Minimum CEFR level B1 English test, in speaking and listening.
- Pass the "Life in the UK" test
- Be of good character
